

This past fall, the program ran seven Level 1 clinics and four Level 2/3 clinics across the province. A total of 115 officials participated, including 100 new officials.

In December, we ran a Community Evaluator clinic in Pickering. Nine experienced officials, representing four regions, took part in the weekend long course, where the basic aspects of officiating at levels 1 and 2 were broken down into their finer details. Congratulations go out to Lyndsey Matsumura, Sam Campbell, Amy Murray, Margareth Peressutti, Darcy Hodgson, Marie-Catherine Laframboise, Patricia Burke, Dan Cockburn and David Bretsznajer for surviving the weekend and completing the course.

On the administration side, I would like to welcome Denise Pelletier to, and Karen Meek back to, the Officiating Committee. Denise has taken over the duties as Western Region Coordinator and Karen has filled the spot vacated by the North West Region. Each brings individual strengths and experiences at different levels that can only help guide this program towards the future. In addition to being a member of the committee, Karen has taken over the role of Evaluations Manager. She succeeds Rob Evans, who I wish to thank for his hard work and dedication, and will now be the central contact for all evaluations and upgrade requests.

I always feel a sense of pride when our officials do well at the national and international levels. Last spring, our province staffed twelve of the twenty-one officials at the Canadian Ringette Championships (CRC's). This past summer, Natalie Fortin from Ottawa and Kevin Lee from Mississauga were selected to represent Canada at the World Ringette Championships held in Finland in November. In August, Lorie Grant, Rob Drury, Danielle Lalonde-Clarkin, Karen Meek, and Janyce Gunn were selected to officiate at the next Canada Winter Games. Out of the ten officials selected to attend these two premier events, eight are from Ontario. Our continued success at the elite levels is a direct result of the hard work done by our evaluators, instructors, supervisors and officials. If we continue to work hard, we will continue to be rewarded.

In July, three of our members, two current and one alumnai, were inducted into the Ringette Canada Hall of Fame. Steve Blacklock, Mark Renkiewicz and Bruce Heaslip all received the greatest honour possible in our sport. I know both Steve and Mark extremely well and I can honestly say that no two people in our program deserve to be there more than them. Both are character people with impeccable resumes which include officiating at CRC's, CWG's and World Championships. Congratulations to these three new members as they have made ORA proud.

This winter will see a change to our Provincial Championship format. There will be three events between February and April: Provincial AA's, Provincial A's and U12 Provincials. The U12 division has been moved out of the A and AA Provincials and a new Championship has been created solely for this age group. This event will premier in Mississauga in April and should create additional developmental opportunities for some of you.

At the National level, the Eastern Canadian Tween Championships has been replaced with the Eastern Canadian Championships. The event has been expanded to include the U14AA, U19A and U16A divisions. This event will be held in Charlottetown in April and with its increased number of divisions, there will be an increase in the required number of officials. This will provide some of you with another opportunity beyond the Provincial level.

As this season will be the last for the current rules cycle, be aware that each and every one of us will have to take a refresher clinic next fall. For those of you who will be eligible to take the Level 2/3 clinic, check with your Regional Coordinator in September for availability. At this point, we are unsure if Ringette Canada will have the Level 2/3 clinic materials available for next year (we typically do not run these during rule change years) but we are hoping that they are.

I would like to welcome back Rick Thomson and Chris Bradt to the evaluating program. Both bring a wealth of knowledge of all things officiating and both will help in the development of officials in their local areas.

On a final note, as this will be the last ROG I work on as Chair of the Committee, I would like to thank two people in particular for their help over the past few years: Derek Burger, who helped me out when I thought my officiating career was over and Karen Meek who gave me the benefit of the doubt when she did not have to. Both people have been instrumental in my officiating career and have helped me out immensely over the past four years as Chair.

Enjoy the rest of the season and I look forward to seeing you around the rink.

ONTARIO OFFICIALS INDUCTED INTO RINGETTE CANADA'S HALL OF FAME

This past June, three officials from Ontario were inducted into the Ringette Canada Hall of Fame. Induction into the Hall of Fame is the highest honour that one can attain in our sport and is recognition of one's outstanding contribution to the game of Ringette and Ringette Canada. Congratulations go out to Steve Blacklock of Guelph, Bruce Heaslip of Hamilton and Mark Renkiewicz of Bowmanville.

Steve Blacklock

Steve Blacklock started officiating in Guelph in 1980 and quickly ascended up the ranks. In 1984 he was selected to officiate at the provincial championships, his first in what would be an impressive run of twenty-five straight appearances. At the national level, Steve officiated at nineteen Canadian Ringette Championships and the past five Canada Winter Games, where he was consistently selected to officiate in the final games. In 1994 and 2004, Steven was also selected to officiate at the world ringette championships. Off the ice, Steve has devoted much of his time to help develop officials and the officiating program. He has served on the Ringette Canada Officiating committee for a number of years and has also served as the rule book editor for two significant periods of rule changes.

Bruce Heaslip

Bruce Heaslip began his involvement with ringette in 1970 as an on-ice official in Hamilton, where for many years, he was a dedicated on-ice official and local Referee in Chief for the Hamilton Ringette Association. He became well known as a successful course conductor and master instructor - training both on-ice officials and course conductors across Ontario and throughout Canada. He was also an on-ice official at the first three Canadian Ringette Championships and attained the highest level of ringette officiating available at the time and he was a supervisor of officials at Nationals for the three years following that. One of Bruce's notable achievements on behalf of ringette officials across Canada was the inception and development of the Officials' Evaluation Program along with Bruce Kettles, Jim Benning and Doug MacQuarrie. Bruce contributed to the development of the officials' evaluation form, performance indicators and key deliverables in the program – many of which are still used today.

Mark Renkiewicz

Mark Renkiewicz began his officiating career in Oshawa in 1969 and remains active in ringette over 40 years later. He officiated at the first Ontario Provincial Ringette Championships in 1975 and has made almost consecutive appearances since that time. Mark was a constant figure at the Canadian Ringette Championships from 1980 through to 2004. In 1981 he was the recipient of the Ringette Canada Air

Canada Official of the Year award and in 1990 was the recipient of the Ontario Ringette Association Referee of the Year award. Besides his on-ice involvement, Mark has volunteered with the local, regional and provincial associations, has served as a local Referee in Chief and has instructed and evaluated young officials in the sport for decades.

ONTARIO OFFICIALS REPRESENT CANADA AT WORLD CHAMPIONSHIPS

This past November, Nathalie Fortin of Ottawa and Kevin Lee of Mississauga represented Canada at the 10th World Ringette Championships, held in Tampere, Finland. This event saw the national teams from Canada, Finland, U.S.A., and Sweden battle it out for ringette world supremacy. Only four officials were selected to work the event and both Lee and Fortin represented Ontario and Canada. Both Fortin and Lee have been mainstays at the National level for most of the last decade and each has officiated Provincial and National Championship final games. This was Kevin's second International event (2008 World Club Championships) and Nathalie's first.



ONTARIO OFFICIALS SELECTED TO WORK CANADA WINTER GAMES

The Canada Winter Games (CWG's) will be held in Halifax, February 11-19, and Ontario officials will be leading the way. Six of the eight officials selected to participate and both supervisors are Ontario residents. Congratulations go out to Brent Bunting, Rob Drury, Lorie Grant, Janyce Gunn, Danielle Lalonde-Clarkin and Karen Meek for being selected to officiate at this prestigious event.

ONTARIO OFFICIALS ATTAIN LEVEL 5 STATUS

Last summer, three of Ontario's officials attained their Level 5 status through Ringette Canada. Level 5 is currently the highest rank an official can attain in Canada and is truly representative of one's consistent excellence at national level events. There are currently only nine Level 5 officials in Canada and seven are from Ontario. Congratulations go out to Robert Drury of Whitby, Janyce Gunn of Oshawa and Danielle Lalonde-Clarkin of Ottawa.



KAREN MEEK NAMED PROVINCIAL OFFICAL OF THE YEAR FOR 2009/2010

This past April, Bowmanville resident, Karen Meek, was named the recipient of the Provincial Official of the Year award for 2009-2010.

During 2009, Karen was selected to officiate at the U19 World Championships in Prague, where she officiated the final game. In addition, Karen participated at the 2009 Canadian Ringette Championships, where she was selected to officiate the NRL Championship game. These two games were the premier events that one could officiate in 2009 and Karen's selection for both is indicative of her on ice excellence.

In addition to her on-ice, Karen is a leader amongst the officiating group and is well respected. She is a Level 5 official, a Provincial evaluator and a Master instructor. Her on-ice and off-ice participation made her the perfect recipient of the Provincial Official of the Year Award for 2010. SHOULDER PADS REQUIRED IN U19

As mandated by ORA this past summer all players participating in the U19 divisions must wear shoulder pads when playing. This requirement now ensures that all divisions below 18+ are consistent with the shoulder pad requirement. Be aware that this requirement is division specific and as such, a U19 player participating in a +18 division game is **not** required to wear shoulder pads during that game. In addition, this requirement does not apply to games involving out-of-province teams or tournament games between teams when out-of-province teams are in that specific division (i.e. all games in the division regardless of whether the actual game involves the out-of-province team are not included in this rule).

Should you become aware of a player who is required to wear shoulder pads and is not, the procedure is to ask that player to leave the ice and not return unless she is wearing shoulder pads. Should that player return to the ice after the warning, she will be assessed a delay of game penalty.

ABUSE TO BE DOCUMENTED ON GAMESHEET

At the request of the Games and Tournaments (G&T) committee this past fall, we have been asked as officials to help track incidents where we feel that we have been abused (verbally or physically) by coaches, players and fans. Should you feel that you were abused beyond that which we normally expect please ensure that it is written at the bottom of the gamesheet with the words "ABUSE" clearly identified along with a description of the event. If this happens, please ensure that your Regional Coordinator is contacted so that they may forward the information to G&T and we can look into what transpired.

OFFICIATING LOSES ONE OF ITS OWN: JOHN BARFOOT

Some of you may remember John as the kind referee who would stop to explain calls to the young girls. He had a way with the younger ringette players, teaching them the game as he went along, explaining and helping them understand how to play. Some of you will remember John as the referee that let the big girls play, only stepping in when it got too rough. Others will remember John on the bench of the Open B team, giving them his knowledge of the game; enjoying himself in

the company of athletes playing a game he loved. And he did love the game... the amount of travelling he did as parent, coach, and especially referee was tremendous. He was the "go to guy" for Sunderland Ringette and Newmarket Ringette Association for many years. He'd travel in from Greenbank for a game or two at the drop of a hat. Many a time he showed up in Newmarket still dressed in his referee clothing, after getting off the ice in Sunderland or a hockey game in Port Perry. He would just put on the skates, helmet and go. Myself, I will remember Johnny B. as a colleague, a teacher of the officiating side of ringette, a mentor of the challenges of ringette, and especially a friend; a friend I will miss at the

arena... his smile, his welcome, his comment. A fellow referee, Rob Drury said "The rink will seem much colder without John." I couldn't have said it better.

UPGRADE REQUEST SYSTEM PROBLEMS

UPGRADE REQUIREMENTS – DO YOU KNOW WHAT THEY ARE?

Upgrade requirements are different depending on the rank you are trying to become. The following are the basic requirements, in addition to completing the required clinic, that one should know when trying to attain a new level.

- Level 1 requires one evaluation from an evaluator or local RIC to move within Level 1.
- **Level 2** requires two evaluations from two different evaluators to move to and within Level 2.
- Level 3 requires three evaluations from at least two different Regional or Provincial evaluators. One evaluation must be from an evaluator based in a different region than the official.
- Level 4 requires four evaluations from at least two different Provincial evaluators. One evaluation must be from an evaluator based in a different region than the official. One evaluation must be on a tournament final game or a game during the Provincial AA's. Upgrade to and within Level 4 must be approved by the Chair of the Officiating Development Committee

A Tale of Two Referees: Life Lessons We Can All Learn From Two of this Summer's Biggest Officiating Blunders (By: Brian Kiley)

Below is an article I found that gives an impressive look at how to handle those mistakes that we make. BB

This summer has been a great one for sports and a tough one for sports officiating. While fans have been dazzled by all sorts of historic individual and team performances in a wide range of events, they have also been subject to the aggravation of the nightmare that takes years off the lives of diehard fans: the missed call by an official.

I have been fascinated to observe the reaction, by fans and officials alike, to some of these blunders, and I believe that two of them in particular can serve as powerful teaching moments for all of us.

The first came on June 2, 2010, in a baseball game between the Cleveland Indians and the Detroit Tigers. Unheralded pitcher Armando Galarraga had pitched brilliantly for the Tigers, and found himself one out away from a perfect game, a game in which the pitcher retires all 27 batters he faces, with no base hits and no walks. There had been only 18 such games thrown in Major League Baseball since 1900. The final batter hit a weak ground ball to the first base side, the first baseman fielded it and threw the ball to Galarraga who was covering first base to make the final out. But Jim Joyce, the first base umpire, called the runner safe. The perfect game was ruined. Players protested, but to no avail. After the game Joyce watched the replay in the umpires room. After watching it once he knew what everyone else in the stadium already knew: He had missed the call. The throw had beaten the runner, and the missed call had cost Galarraga a perfect game.

The second took place on June 18, 2010 in a World Cup soccer match between the United States and Slovenia. The United States had trailed 2-0 at halftime, but had made a furious comeback to tie the game at two. In the 86th minute Landon Donavan put a free kick into the penalty area from the right side, and Maurice Edu managed to get a foot on it to put it in the goal and give the United States a 3-2. However, referee Koman Coulibaly indicated that a foul had been committed on the play. He nullified the goal and awarded Slovenia a free kick. The game ended in a 2-2 draw, and Coulibaly became the recipient of venomous international outrage as talking heads tried to make sense of what he could have possibly seen on the play that warranted such a call.

Both men made mistakes in critical moments. Both men were subject to incredible amounts of criticism in the wake of their decisions. Both men's names were Trending Topics on Twitter and were the number one search term on Google for a short time following their respective incidents. But the reaction that the two men had to their mistakes could not have

been more different, thus the two men are remembered very differently.

Upon seeing the replay on his blunder Joyce, a 22-year veteran of Major League Baseball umpiring and a man regarded as one of the best in the game, began to weep. He immediately left his locker room and sought out Galarraga. With tears in his eyes he apologized to the pitcher and to Tigers manager Jim Leyland, both of whom graciously forgave him. Joyce then stood up and faced the music as reporters peppered him with questions. He admitted that he blew the call, and said that there was nobody who felt worse about it then he did. Despite the crushing guilt he felt, Joyce answered every question he was asked. The following day he was scheduled to work as the home plate umpire for another Detroit Tigers games, and with the exception of a few scattered shouts, Tiger fans greeted Joyce warmly. He and Galarraga shared a handshake prior to the game. The behavior of both Joyce and Galarraga following the blown call made this one of the great stories of sportsmanship in recent memory.

Coulibaly on the other hand, was scarcely heard from following his blunder. When players on the field asked what the call had been, he did not answer. FIFA referees are not required to publicly comment on their matches, so he didn t. Even several days later when he granted an interview request, he declined the opportunity to discuss the call, or even say what call he had made on the controversial play. He was, in a sense, the anti-Joyce.

On the one hand, I sympathize with Coulibaly s error. If there is one thing I learned from watching the World Cup this year, it is that human beings are not capable of refereeing soccer matches. The task is just too difficult. There is too much to watch. I hate that individuals are put in positions where they have to make split second decisions in front of a television audience of millions of rabid fans that are ready to demonize them for the slightest mistake. However, it is frustrating to see a man make a mistake like that on a stage like that and refuse to own it. The public anger that sports officials are subject to when they make mistakes shows that we, as a society, care about sports entirely too much, but that does not change the fact that the right thing for Coulibaly to do would have been to admit his mistake.

Just weeks after Joyce's blown call ESPN the Magazine conducted an umpiring survey of 100 Major League players. Joyce was voted Best Umpire by an overwhelming margin. I have to imagine that vote is not only a testament to Joyce's stellar work on the field over the years, but also a testament to the courage and integrity that Joyce showed in the worst moment of his career.

The bottom line is that it is much easier to own up to those mistakes we make on the ice than to pretend they never happened, or to make excuses.
